As you may be aware, Hong Kong (China) currently ranks fifth among 154 countries and territories investing in Vietnam, with 3,331 projects and total registered investment capital exceeding USD 40.7 billion. In recent years, numerous leading corporations and business delegations, particularly in the fields of high technology, electronics, electric vehicles, medical devices, pharmaceuticals, energy, and related industries, have continuously visited Vietnam to explore investment policies, assess potential project locations, and establish business operations in the country.

Recognizing the continued growth of investment from Hong Kong into Vietnam, **IPAVIETNAM, in collaboration with the Hong Kong Trade Development Council (HKTDC)**, is organizing a business delegation to participate in investment networking activities within the framework of the Belt and Road Summit 2026 in Hong Kong. The Belt and Road Summit is a major annual economic event jointly organized by the Ministry of Commerce of the People's Republic of China and the Government of the Hong Kong Special Administrative Region since 2015. The Summit attracts more than 6,000 international delegates representing multinational corporations and enterprises from over 70 countries and territories, particularly companies from Mainland China, seeking opportunities for cooperation, investment, and business expansion.

These activities will provide valuable opportunities for participating enterprises to directly engage with potential partners and investors, promote their projects, products, and services, explore cooperation opportunities, attract investment, and expand into international markets.

The delegation is particularly suitable for enterprises operating industrial parks, industrial clusters, warehouses, and ready-built factories; manufacturers and suppliers in supporting industries; service providers serving FDI enterprises, including law firms, investment consulting firms, construction companies, tax advisory firms, banks, human resource service providers, logistics companies, and related sectors; as well as organizations and enterprises seeking opportunities for international cooperation and business development.

All expenses related to participation in the program shall be borne by the participating enterprises, including registration fees for the Belt and Road Summit, participation fees for the investment promotion seminar "*Hong Kong Connect 2026*", costs associated with arranging meetings with organizations and business associations, Hong Kong entry visa fees, round-trip airfare, hotel accommodation, meals, and local transportation in Hong Kong. *(Please contact us for a detailed quotation.)*
